**Wednesday, March 13, 2019** Today, we will leave Indianapolis by bus and head to our destination in Montgomery, Alabama, where we will check into the Double Tree hotel located in the downtown area.

**Thursday, March 14, 2019** We enjoy breakfast at the hotel and then will spend the day visiting the historic sites of Montgomery including the Dexter Ave Baptist Church, and the home of Dr. King.



After lunch, we will take a short tour of Montgomery and see the site of the bus boycott, visit the Rosa Parks Museum and the Southern Poverty Law Center. Overnight in Montgomery.



**Friday, March 15, 2019**

After breakfast at the hotel, we will visit the Legacy Museum: From Enslavement to Mass Incarceration. This afternoon, we visit the National Memorial for Peace and Justice.

Tonight, we will have an included dinner at Martha's Place, a local favorite.



**Saturday, March 16, 2019** Following our breakfast, we head back to Indianapolis,

**Cost:** The cost will be \$699.00 per person (double occupancy) and includes all bus transportation from Indianapolis to Montgomery and back, Three nights in hotels (dbl occupancy) one group dinner, daily breakfast and Museum admissions. Not included: personal gratuities; excursions, wines, liquors, mineral waters and meals not mentioned in the itinerary, travel insurance; all items of a strictly personal nature

**Payment Schedule:** A deposit of \$200.00 per traveler will be due to confirm the space by December 15, 2018 Final Payment as invoiced will be due January 15, 2018.

**Cancellation:** Once you have made a payment, If you must cancel before 120 days prior to the trip, you will be entitled to a full refund. Between 120 days and 30 days prior to the trip, you will be entitled to a refund of the total trip cost less the cost of any non-refundable deposits paid to hotels and other vendors. If you cancel less than 30 days prior, there will be no refund. Cancellations after 120 days prior to the trip will incur a \$50 administrative fee.

**Trip Insurance:** Trip insurance may be purchased to protect the cost of the trip in case of a last minute emergency. To cover pre-existing conditions, trip insurance must be purchased within 14 days of the initial deposit. Once you have placed a deposit for this trip, I will provide you with a brochure that you may choose to use.
