Monday, July 27

This afternoon, we will join a guided walking tour of the Santa Fe Plaza and see the many galleries and restaurants within easy walking distance of our hotel.

This evening, we have tickets for one of the many offerings of the Santa Fe Music Festival. Specific performance will be determined when the schedule is announced.



Wednesday, July 29 Enjoy a bountiful breakfast buffet this morning. This evening, we will meet for a light dinner before we transfer to the spectacular Santa Fe Opera House for a special performance of the Dvorak opera, Rusalka. Mark will give us some thoughts on the opera and the best way to enjoy it.



Thursday, July 30 After breakfast at the hotel, enjoy the day with some free time to wander the streets of Santa Fe on your own. This afternoon, we will take a culinary progressive lunch visiting a number of the highly acclaimed restaurants in the area. Each course will be accompanied by a special local wine.

Friday, July 31 After breakfast, we will depart for Albuquerque, a short 90 minute bus ride, where we will check into another beautiful 5 star hotel located in the old town area. The Hotel Albuquerque offers a distinctive blend of historic grandeur and contemporary comfort and is conveniently located in the heart of Old Town,



Tonight, we have tickets for a special show by the Tablao Flamenco.

Saturday, Aug. 1 Spend the day walking the Old Town of Albuquerque and discovering some special shopping opportunities. Enjoy lunch at one of the many fine restaurants. This evening, we will gather for a special closing dinner and some surprise entertainment.

Sunday, Aug. 2 Our flight departs from Santa Fe later today and we arrive back in Indianapolis after a memorable week of excellent music, incredible food and fine wines. Our flight gets us back to Indianapolis in the late afternoon hours.

This amazing seven day/six night trip includes round trip airfare from Indianapolis, all local transportation, four nights at The Eldorado Hotel and Spa (double occupancy), a welcome reception, breakfast each day, a local tour of Santa Fe with lunch and wine tastings, tickets for one concert presented by the Santa Fe Music Festival, ticket for the Santa Fe Opera, two nights at the Hotel Albuquerque, ticket for the Tablao Flamenco show and a closing dinner.

Cost:

This itinerary includes 6 nights and 7 days, round trip airfare from Indianapolis, the hotels and meals as listed above. The cost is \$ 2499.00 per person (double occupancy)

Not included: personal gratuities; excursions, wines (not mentioned in the above itinerary) , liquors, mineral waters and meals not mentioned in the itinerary, travel insurance; all items of a strictly personal nature

Pre and Post tours and use of Frequent Flyer miles can be arranged as requested.

The price is based upon cash or check payments. Payment by credit card will incur an additional fee of 3%.

Payment Schedule:

A deposit of \$500. per traveler will be due by September 1, 2019.

A payment of \$1000 per traveler will be due January 15, 2020

Final Payment as invoiced will be due May 15, 2020.

Cancellation:

Once you have made a payment, If you must cancel before 120 days prior to the trip, you will be entitled to a full refund. Between 120 days and 30 days prior to the trip, you will be entitled to a refund of the total trip cost less the cost of the airline ticket and any non refundable deposits paid to hotels and other vendors. If you cancel less than 30 days prior, there will be no refund. If you cancel after 120 days prior and the airfare has been paid, you may be entitled to an airline credit less the change fee assessed by the airline. Usually you have one year to use the value of the ticket minus the change fee set by the airline. Cancellations after 120 days prior to the trip will incur a \$100 administrative fee.

Trip Insurance:

Trip insurance may be purchased to protect the cost of the trip in case of a last minute emergency. To cover pre-existing conditions, trip insurance must be purchased within 14 days of the initial deposit. Once you have placed a deposit for this trip, I will provide you with a brochure that you may choose to use.

Baggage: Checked baggage fees vary by airline. For most domestic routes, you will be charged \$25.00 per checked bag. Please check the website for specific prices. You will be allowed a small carryon and one personal bag. Please be sure you meet the specifications for the carry on bag so you are not surprised with a charge at check in.

Selection of Vendors: Travel to Remember, LLC will use the following guidelines for the selection of international and domestic land and air suppliers.
